

STATE OF THE TOWN

Throughout 2006, the Meridian Hills Town Council continued to responsibly manage your Town government. We during this last year in office:

• Transferred \$30,000 to the Rainy Day Fund bringing the fund total to \$89,000



• Successfully appealed to state gov-

ernment to recover additional \$11,076

- Received \$11,752 from Major Moves and expect an additional \$11,000
- Approved a balanced budget for 2007
- Successfully lobbied City to modify ordinance language to recognize Town setbacks prior to issuing a building permit

- Modified enforcement provisions in the Town Municipal Code
- Completed Defibrillator Protocol and Police Training
- Hosted DPW for a "Drainage 101" presentation
- Successfully lobbied to have city repair drainage culvert on Williams Creek Boulevard
- Completed 15 year Town Road Life Analysis
- Completed Town inventory of speed limit signs and street name signs
- Successfully lobbied to have city install advanced pedestrian signs on 71st near Penn
- Installed new yellow-green fluorescent "Stop Ahead" signs on Pennsylvania

were able to achieve some great accomplishments over the last year thanks to the hard work and dedication of your elected officials, the contributions of time and talent by volunteer residents, and the continued guidance and knowledge of qualified professionals serving on the Town Administration.

Following are some of the accomplishments

Council Considers Match Program To Achieve Town Beautification Goals

The council approved the design for new Town Entry and Street Name signs and Decorative Streetlights recommended by the Town Planning Committee. The entry sign's estimated cost is approximately \$6,000, the decorative streetlight ap-

proximately \$2,500, and the street name sign approximately \$500. From our \$264,000 disbursements in 2006, \$88,000 went to police, \$78,000 to street maintenance & snow removal, and the balance to utilities, taxes, insurance, mainte-

nance and compensation.

Although we continue to explore alternative funding, the council cannot accomplish all the beautification goals as desired. We created a Town Beautification Fund to allow interested





2006 Financial Summary

Below is a financial summary of 2006 showing approximately \$315,000 of receipts and \$264,000 worth of disbursements. The difference is thanks to a mild winter requiring less snow removal, and the first installment of \$11,752 the Town received from Major Moves. Our primary disbursements are for police protection and street maintenance.







Any match would be based on the Town's available funds, as we continue to be responsible for ongoing road maintenance and police protection. 10 STEPS FOR MERIDIAN HILLS RESIDENTS

- Call 9-1-1 to report suspicious activity
- Drive the speed limit (then everyone behind you will!)
- Trim trees and shrubs blocking traffic signs near your property
- Remove leaves & debris from stormwater drains near your property
- Remove unauthorized signs on poles or corners near your property
- Remove trash and weeds along the road near your property
- Contact the Town prior to any major remodeling or building for plan review
- Volunteer to serve on a Town Committee
- Donate to the Town Beautification Fund
- Get to know your neighbors to keep an eye on each other & visit the elderly and those living alone

Once a few of the new signs go up, more residents may donate once they see how nice they are.

- Installed new "Speed Limit" and "Children Playing" signs where deficient on high-volume cut-through streets
- Reduced Town Speed Limit from 30MPH to 25MPH on local roads
- Sent letters, emails & phone calls to local churches, schools, and township bus director informing of speed limit reduction & stepped up enforcement & requested their cooperation



- Created ad hoc Town Planning Committee to study long-term issues to improve safety, property values, livability and community
- Received over 350 surveys from the first ever Town-wide Resident Survey
- Hosted Public Town Planning Meeting

Streets & Thoroughfares

Meridian Hills has approximately 11 miles of streets we're responsible for maintaining, including snow removal, traffic signs, pothole repair and repaving. Although we rely on professional advice from our engineer, the Streets & Thoroughfares Committee studies many of these issues and makes recommendations to the Council. The committee is chaired by Kay Ivcevich and currently consists of Kay, Perry Jordan and Suzanne Bellamy.

They work with our engineer to develop actions necessary to maintain, construct and preserve the streets in our Town so we have a high quality system focusing on safety, efficiency, and convenience for residents. They recently recommended our 15 year roadway analysis, speed limit reduction, and methods to curtail speeding.

Town Election This Year

The Town of Meridian Hills has an election year in 2007. Since two current officials have decided not to run

for re-election, there is a need for new people to get involved. The four elected positions include:

- (3) At-large Council Members
- (1) Clerk Treasurer

This is a great opportunity to participate in your government at a local level. Although a candidate may run with any party affiliation, if an elected official

cannot fulfill their 4-year commitment for any reason, a candidate who runs as an independent allows for more local control since the replacement is appointed by the Town Council rather than the county-level chairperson of a political party. (This actually happened twice in the past three years.)

The Marion County Election Board processes our elections during the general election the first Tuesday in

November. A candidate must sign a Declaration of Candidacy and Petition of Nomination with resident signatures no later than July 2nd in order to be an independent candidate in the fall election. The deadline is February 23 for those wishing to run with a party affiliation. Interested residents are encouraged to attend

the monthly council meetings and participate at a committee level to get a better understanding of the job. For more information, please call one of your elected Meridian Hills Town officials or the Marion County Election Board at 327-5100, or visit meridianhills.org.
