The meeting was called to order at 7:00PM. After the Pledge of Allegiance, President O'Brien called for a Moment of Silence in remembrance of the events of September 11, 2001.

## Town Attorney Report

Sue Beesley remarked that the speed limit ordinance passed, subject to legal review, at the August 2006 meeting was in violation of a new state law passed in 2006 which calls for a traffic study where the speed limit falls below 25 MPH. The Town has 5 options:

- \*\* Let the ordinance stand
- \*\* Repeal the ordinance
- \*\*Keep at 20 MPH and complete a traffic study
- \*\*Amend speeds to 25 MPH from 20 MPH, grandfather current 20 MPH limits
- \*\* Amend all speeds to 25 MPH

Cecil Whitaker then discussed the possibility of a line of sight, standard driven study. A motion was made to ask Cecil Whitaker to complete research of what kind of study is needed and how involved this would be. This motion was seconded and approved 3-0.

## Police Report

Mike Russo mentioned a monitoring of school bus speeds completed last August 17. 17 buses were clocked with the fastest speed clocked at 32 MPH on 75<sup>th</sup> Street. Mike also encouraged residents to report solicitors in the area- 5 or 6 have been stopped within the last month.

## Approval of Minutes from August 14 Meeting

A motion was made to approve the August 14 minutes, as amended. This was seconded and approved by a vote of 3-0.

## Town Engineer Report

Engineer Whitaker reported briefly on the issues of Drainage and Roads. Without regard to the costs of any drainage issues, paving alone on the roads is estimated to be \$70,000 next year, and \$100,000 in 2008. "Once the base is lost, that's it," remarked Engineer Whitaker.

## Streets & Thoroughfares Committee

Letters were sent to schools, churches & Washington Township Transportation Director asking for their cooperation redirecting busses and addressing speed control within the Town. Additionally, the City has installed two advanced pedestrian crossing signs as requested on 71<sup>st</sup> near Pennsylvania compliant with our new sign standard.
