

APPROPRIATION ORDINANCE NO. 2022-1

**AN APPROPRIATION ORDINANCE FOR THE TOWN OF MERIDIAN HILLS,
INDIANA, TO APPROPRIATE FROM THE ARP CORONAVIRUS LOCAL FISCAL
RECOVERY FUND AND GENERAL FUND FOR PURPOSES THAT FULFILL THE
INTENT OF THE AMERICAN RESCUE PLAN ACT
IN AID OF THE TOWN OF MERIDIAN HILL'S RECOVERY FROM THE EFFECTS
OF THE COVID-19 EMERGENCY**

WHEREAS, on March 11, 2021, the American Rescue Plan Act of 2021 ("ARP") was enacted;

WHEREAS, the ARP provides \$350 billion in emergency funding to state and local governments and the Town of Meridian Hills (the "Town") is a recipient of that funding; and

WHEREAS, the Indiana State Board of Accounts has provided guidance to funding recipients;

WHEREAS, on March 14, 2022, in accordance with the requirements of the Indiana State Board of Accounts, the Town Council adopted Ordinance No. 2022-1 establishing the ARP Coronavirus Local Fiscal Recovery Fund ("ARP Funds")

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MERIDIAN HILLS, INDIANA ("TOWN COUNCIL"), THAT:

Section 1. For the expenses of said Municipal Corporation, the following additional sums of money are hereby appropriated and ordered set apart from the fund herein named and for the purposes herein specified, subject to the laws governing the same;
