1) CALL TO ORDER

2) **RESIDENT FORUM -** *Please limit comments to five minutes*

- **A.** Resident Sean McGoff whose home is on W. Holliday Drive reported that there are a number of residents who have expressed concern for the safety of children crossing W. 75th Street on their way to and from school at St. Luke's Catholic School. .President Freihofer acknowledged the need to be vigilant and to protect the children. Marshal Russo also spoke to it as well.
- **B.** Resident Beth Mills reported that the traffic to the Park Tudor School was backing up and causing drivers to block her driveway and turn around in her driveway. President Freihofer said that he would call the school administration to discuss the inconvenience with the administration.

A. MARSHAL RUSSO INDICATED THAT REQUESTS HAD BEEN RECEIVED TO ADDRESS THE SPEED ON MERIDIAN STREET AND THEY WOULD BE DOING THAT.

B. Councilor Marr asked Marshal Russo if the protests referred to in an email Russo sent on 9 Sept occurred as predicted. Marshal Russo replied that the protests were organized by PETA (People for the Ethical Treatment of Animals) and occurred at the home of the Eli Lilly and Company Chief Executive Officer, on Washington Blvd on Thursday 10 September 2020. He said the protest activity was orderly, and without incident. This was the second time PETA protested at the home and will likely not be the last. PETA has been professional and cooperative with respect to their protests and are easy to work with. Meridian Hills officers were posted at the site during last week's protest, along with the Indianapolis Metropolitan Police.

- A. Reported that NIP request had been approved that would net Town approximately \$60k for project just completed.
