## 2) RESIDENT FORUM –ATTENDEES WAS REPRESENTATIVE OF THE TOWN'S RESIDENTS

- A. Colleen Field communicated questions that she had received from Residents about the 5G that would be built in the town.
  - a. The response from Resident John Grotland, who represented himself as someone who had worked in that industry indicated that most towers would be included on the current towers that are in place.
  - b. Councilor Freihofer indicated that he did not have knowledge that suggested that the Town would have any authority in the location of the towers.
  - c. Town Engineer Hall indicated that thought that most of the current construction were Fiber installations but would inquire.
  - d. Attorney Cochran indicated that it was his understanding that the State of Indiana State legislature stripped State municipalities from limiting authority for installations of 5G.
- B. Resident John Grotland expressed a guidance on the development and installation of the Side Walk. His primary motive that he expressed was for planning to meaningful plant movement. President Freihofer and Councilor Jacoby both indicated that the timing was undefined at this time but encouraged Mr. Grotland to begin as soon as possible to assure that there would not be any un unneeded damage.
