

RESOLUTION NO. 2022- 1

WHEREAS, the Town Council ("Council") of the Town of Meridian Hills, Indiana ("Town") has determined that it would be of public utility and benefit and in the best interest of the Town and its citizens to make the following reductions in the 2022 Budget, as adopted by the Council on October 11, 2021 (the "2022 Budget"); and,

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF MERIDIAN HILLS, INDIANA, AS FOLLOWS:

Section 1. Reduction in 2022 Budget. The Council hereby makes the following reductions in the 2022 Budget:


