# TOWN COUNCIL MEETING MINUTES JULY 8, 2024, 7:00 PM

- A. Updated Monthly Report. The updated inventory was discussed briefly with no questions.
- B. 2024-01 Pavement Maintenance Update
  - i. Contract work completed June 11, 2024 / Original Contract Date: May 31, 2024
    - It was discussed that not all pavement markings have been completed at this time, so the project is considered not complete and subject to additional liquidated damages.
    - ii. The potential enforcement of liquidated damages was discussed, and it was determined that we will continue to monitor the completion of the project prior to making a determination on the liquidated damages.
    - iii. No schedule has been provided for Raised Crossing partial replacement, finish work and final walk-through at this point. Howard will be required to provide advance notification prior to any permitted lane closures/restrictions.
    - iv. The expectation is that this would all be paid in one pay estimate at the September meeting.

### C. Funding Applications:

- i. 2024-01 CCMG Application-Previously Approved (see bid opening)
- ii. 2024 Indy NIP Application- APPROVED Indianapolis approved the application in the amount of \$40,445.

#### D. 2024-01 CCMG Paving Project Update

- The apparent lowest and most responsible and responsive bid was from Midwest Paving LLC in the amount of \$246,877.69. See attached bid tabulation results. It was recommended to award the project to Midwest Paving LLC and it was approved contingent upon a full review of the bid documents on New Business Unanimous Vote Yes 5-0
- E. 75<sup>th</sup> Street Sidewalk Update All work has been completed, including the re-seeding work, and we will be submitting a final invoice for payment (\$3,500)
- F. 2024-02 CCMG Town authorized CRE to review previous pavement ratings to determine if there is second paving project that could be completed in the range of \$200,000 (Town match = \$50,000). CRE will investigate and respond back to Town prior to CCMG deadline.
- G. 71st Street and Pennsylvania Street Town authorized CRE to investigate improvement options for the intersection and coordination with Indianapolis. CRE to report on findings. Town also authorized CRE to direct Morphey to install full length reflector strips on both sides of 71st and Penn Stop Sign that is within pavement.
- H. Utility Markings and Staking along 75th Street Sandra Welsh (160 E. 75th Street) indicated that a lathe and utility markings had been completed at various locations along 75th Street. CRE reviewed and determined that they were layout for Detour Route Marker Assemblies for Indy DPW's upcoming closure of College Ave. Willie responded via text to Sandra with the answer.

- J. For Ryan E. Mann, we are currently getting the bids scanned in, and as soon as we do, I will get you Midwest Paving's bid for you to prepare the agreement for execution. As a reminder, we need to be under contract with Midwest and paperwork in order and to INDOT at the beginning of August.
